Innovation aid for SMEs, not exceeding €200,000 per company over 3 financial years or, De Minimis aid, not exceeding €200,000 per company over 3 financial years.

## Who Can Apply:

Startups and SMEs from EU member states are eligible to apply if they fulfill certain criteria, including being legally incorporated in a EU member state, meeting the EU definition of an SME, and demonstrating a minimum TRL of 4 for their AI or robotics solutions.

## **Application Process:**

The application process involves several phases, including eligibility assessment, evaluation, and approval to gain access to the Portuguese TEF-Health services catalogue.
